- **Security Guard (Static); Installer (Intruder Alarm)**


The Private Security Authority has approved your application and your licence to provide a security service in the above sector is enclosed. This licence is conditional on you continuing to meet the standards specified by the Private Security Authority. Failure to comply with these standards will result in your licence being suspended or revoked.

Your licence will expire on **14/08/2010** 2 years from the date of issue, unless sooner surrendered or revoked in accordance with section 22(4) of the Private Security Services Act 2004.

The Certification Bodies approved by the PSA to certify companies with the relevant standards for the purpose of PSA licensing must, in the event of a major nonconformity being raised, report the matter to the PSA immediately. Failure to correct the nonconformity will result in the company's licence being suspended or revoked.

I wish to bring to your attention Section 36 of the Private Security Services Act 2004, which requires a licensee, who has been convicted of an offence, or against whom proceedings for such an offence are pending, to notify the Private Security Authority, in writing, within 3 months of the conviction or institution of the proceedings.

You are required to notify the Private Security Authority of any change to the details provided in your application, such as change in director, address, etc.

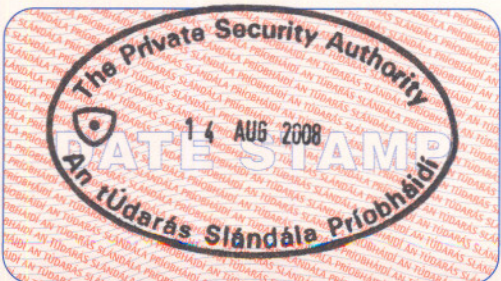
