#### **Submission Guidelines**

Please ensure you have provided adequate detail to allow the judges to score your company against each of the outlined criteria for assessment. When outlining your service delivery in the above areas, approximately 100-200 words would be a good indication of a minimum word count for each assessment criteria. Therefore, as a guide 500 – 1000 words per company submission would allow for an outline of each area to addressed.

The client support letter or letters (as applicable) should also outline their evaluation of the security company against the criteria outlined above and as a guide should be no less than 200 words.

We have not set a minimum or maximum word count for submissions. The information above has been provided as a guide to assist ISIA member companies with preparing their submissions. The assessment and judging will be carried out based on the submission, Therefore, please ensure all relevant information is contained in the submission.

## The Award

The Client Service Award will be announced at the ISIA Awards hosted online on the 26<sup>th</sup> of November 2021.
