CRITERIA FOR NOMINATION

This award enables the Security Industry to recognise those security companies who are delivering exceptional service to their client base. The award is intended to foster and encourage client focus and high standards in the delivery of security services.

ISIA members are invited to submit up to one nomination which serves as an exceptional example of delivery of their security service to the client. The submission should highlight the delivery of their service to the client outlining their strengths in the following areas which will be weighted as indicated below.

- Client Focus (50%)
- Planning & Organisation (20%)
- Our People – (20%)
- Innovation & Added Value (10%)

A statement of support must be included from a client or clients (as applicable). The ISIA is happy to not name specific clients if requested and all details of submissions will be held in strict confidence.

Submission Guidelines

Please ensure you have provided adequate detail to allow the judges to score your company against each of the outlined criteria for assessment. When outlining your service delivery in the above areas, approximately 100-200 words would be a good indication of a minimum word count for each assessment criteria. Therefore, as a guide 500 – 1000 words per company submission would allow for an outline of each area to be addressed.

The client support letter or letters (as applicable) should also outline their evaluation of the security company against the criteria outlined above and as a guide should be no less than 200 words.

We have not set a minimum or maximum word count for submissions. The information above has been provided as a guide to assist ISIA member companies with preparing their submissions. The assessment and judging will be carried out based on the submission, Therefore, please ensure all relevant information is contained in the submission.

9. One nomination will be chosen as the overall winner for the ISIA Client Service Award.
10. The Judges' decision is final.
